1. Confirmation of Minutes from 2021 AGM

<u>Reason</u>: Amendments of the current constitution (rules) of Glen Innes Business Association are required to ensure those rules pertaining to the BID programme and BID targeted rate grant are not inconsistent with Auckland Council's Business Improvement District (BID) policy.
